COOKIE POLICY

1. PURPOSE

This Policy has been prepared to inform the visitors of our website about the cookies that may be used on our website.

2. WHAT ARE COOKIES?

A cookie is information stored on your device by the website you visit. Cookies record your actions and preferences during your browsing session or for your next visit to our website. This allows our website to recognize your device automatically during your next visit and restore your settings for your convenience. The information recorded via cookies by our website is limited to what you provide. Information you do not share with us cannot be accessed. Additionally, cookies cannot access other files on your computer.

3. WHAT ARE COOKIES USED FOR?

Cookies are used to improve our website by recording your actions and preferences on the device you use to access it, and for automatically loading the saved settings when you visit again using the same device, providing you with ease of use.

For example, cookies are primarily used for the following purposes:

- Ensuring the proper functioning of the website (e.g., displaying text, images, links, etc., correctly on the site)
- Providing a more personalized and engaging experience for visitors (e.g., offering services tailored to your preferences)
- Improving and optimizing the website (e.g., making pages with errors or those that are less preferred work properly)
- Remembering visitor preferences (e.g., the information you enter when logging in to our website, language preferences, etc.)

4. WHAT TYPES OF COOKIES ARE THERE?

- **Session Cookies:** Temporary cookies that remain on your device until you leave the website.
- **Persistent Cookies:** Cookies that remain on your device's hard disk for longer periods, ranging from a few days to several years.
- **Necessary Cookies:** Cookies required for the proper functioning of the website.
- **Performance - Analytical Cookies:** Cookies used to gather statistical information such as page views, click information, time spent on a page, etc., for the analysis of website usage.
- **Functional Cookies:** Cookies used to personalize the website and remember your preferences.

- **Advertising and Marketing Cookies:** Cookies that track users' behavior online and analyze their activities, enabling the profiling of individuals and matching them with appropriate advertisements to be shown to the user.

5. OUR USE OF COOKIES AT ART SHIPBUILDING AND SHIP REPAIR SERVICES INC.

5.1. Who Sends Cookies During the Use of Our Website, and How Are They Sent?

Cookies may be sent:

1. By ART Shipbuilding and Ship Repair Services Inc. and/or
2. If the page you visit contains video, image, or other content, by third parties through communication established between the browser on your device (such as Google Chrome, Safari, etc.) and servers.

5.2. How Do We Use the Information We Collect from Your Device?

Cookies:

- Help us remember your browsing and usage preferences during your visit to our website,
- Assist in remembering your preferences, including information you entered in surveys or evaluations on our site,
- Help us collect usage data, such as the frequency of clicks and pages visited, anonymously, for statistical purposes.

We do not use the data collected through cookies to identify you. Cookies will not be used for purposes other than those specified in this Policy and will not be processed in violation of data protection laws.

5.3. How Can I Control Cookies?

You are not required to accept cookies to use our website, but doing so may reduce the quality of your user experience. You may delete cookies or set your browser to block cookies, but in this case, some services on our website may not function as expected.

6. LEGAL BASIS AND METHOD FOR COLLECTING COOKIES

For cookies that are necessary for the operation of the website, the legal basis for processing is "the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject," as stipulated by the Law on Personal Data Protection No. 6698 ("KVKK"). For other cookies, we rely on "the presence of explicit consent" as the legal basis.

You can provide your explicit consent by accepting cookies through the "Cookie Control Panel." All cookies are collected automatically through the website. You can view the cookies used on our website and modify your preferences through the "Cookie Control Panel."
